Flush filter by running water through filter according to cartridge instructions.

Refer to Installation, Operation & Maintenance Manual for cartridge flushing and startup.

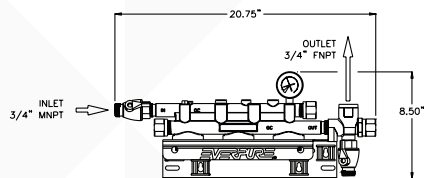
## OPERATION TIPS

Change cartridges on a regular six (6) month preventative maintenance program.

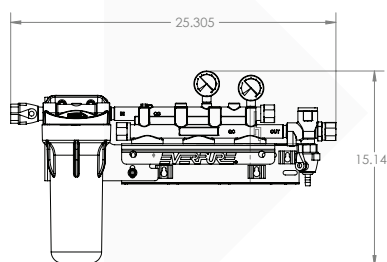
Change cartridges when capacity is reached or when pressure decreases.

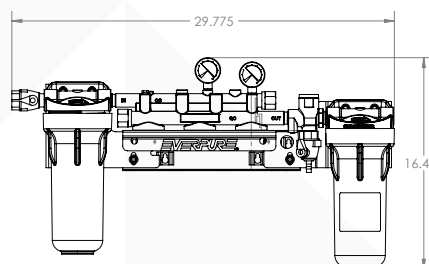

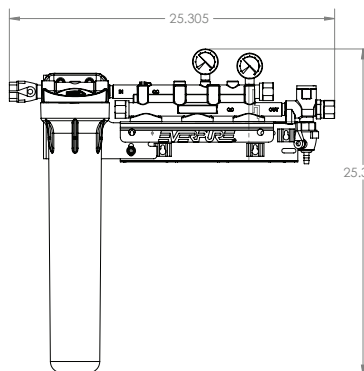
QC71 Triple Head: EV9272-23



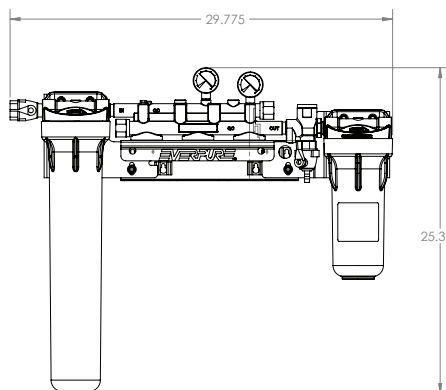
Coldrink/Insurice Triple Manifold with 10" Prefilter: EV9293-03
